A regular meeting of the Mayor and Council of the City of Lyons was called to order by Mayor Brink at 5:30 P.M., September 2024, at Lyons City Hall. Upon roll call, the following Council members were present: Allen Steinmeyer, Kyle Phillips, Tyler Vacha and Matthew Carr. Also in attendance were City Clerk Whitney Anderson, Utility Supervisor Terry Ueding, Library Director Mike Heavrin, City Attorney Matthew Munderloh, and Chief Svendsen.

Visitors included Gary Loftis with Lower Elkhorn NRD, Ric Ortmeier, CPA and Alyson Pedro.

### I. ROUTINE BUSINESS

Mayor Brink publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held. - 1. Gary Loftis, a director for the Lower Elkhorn NRD, presented the council with a check for \$4,950 for the completion of phase 2 of the City of Trees project through the Community Forestry Incentive Program. The project involved planting 33 trees in the parks and boulevards of Lyons.
- 2. ORDINANCE NO. 774 has been passed, approved, and available in pamphlet form.

- 8. Motion by Phillips, seconded by Carr to approve a memorial bench to be placed at Brink Memorial Park for Duane & Dorthy Slaughter. On roll call, AYE: Vacha, Steinmeyer, Carr, Phillips. NAY: None. **MOTION CARRIED.**
- 9. The October Regular Council Meeting will be rescheduled for Tuesday, October 15, 2024.
- 10. Police Report Chief Svendsen Chief Svendsen presented the August police report, which included 14 calls for service and 20 ordinance violations. Aaron Brensel was hired full-time as a Patrol Sergeant. Matt Schott will be surveying the town for security cameras.
- 11. Library Director Mike Heavrin Library and Grant Report: Income in June was \$147.30 and this is \$50.62 below the monthly budgetary goal. Income for the fiscal year totals \$7,120.73 which is \$2,841.95 above our FY 2023-2024 goal. Expenses for June came to \$5,488.02, which was \$611.77 above the monthly budget. Fiscal year expenses total \$43,730.92, and that is \$155.33 below the approved budget for this point in FY 2023-2024.
  - Clerk Anderson asked Heavrin if this was a typo since we received June numbers last meeting. Heavrin responded that he attached the wrong month to the report and will provide the council with July's numbers after the meeting.
  - Heavrin is searching for grant opportunities that would fund the replacement of streetlights in the business district. The Safe Streets and Roads for All Grant is expected to open in early 2025 and can be utilized for recreational projects, improving access for people with disabilities, as well as for trails and campgrounds in rural areas.
- 12. Utilities Report Terry Ueding
  - a. Ueding asked the council if they think we should require concrete permits to be approved in the same process as building permits. Attorney Munderloh is going to review the Codebook and send back his recommendations.
  - b. School Traffic Signs have been installed for no parking and school zones.
  - c. Patching black top roads will not be completed this Fiscal Year due to other projects needing to be completed in September.
  - d. Ueding asked the council if he could start the process of ordering a new skid loader for the next fiscal year and received approval.

e. Lead Pipe Survey is due at the end of September, and we will be conducting door-to-door visits to collect responses.

### 13. Clerk's Report – Whitney Anderson

- a. Clerk Anderson presented the August Treasurer Report. Motion by Carr, seconded by Vacha to accept Clerk Anderson's Treasurer Report. On roll call, AYE: Phillips, Steinmeyer, Vacha, Carr. NAY: None. **MOTION CARRIED.**
- b. General, Utility, and Debt Service Income Statements for the month ending August 31, 2024. The General Fund had a month-to-date net loss of \$53,816.97 and a year-to-date net gain of \$51,911.54. The Utility Fund had a month-to-date net gain of \$10,397.09 and a year-to-date net gain of \$156,911.01. Debt Service had a month-to-date net gain of \$3,955.23 and a year-to-date net loss of \$32,476.85.
- c. Budget reports for the eleventh month (91.6%) on the General, Utility, and Debt Service Funds were as follows: General Receipts were 54.67%. General Expenses were 51.75%. Utility Receipts were 100.70%. Utility Expenses were 86.76%. Debt Service Receipts were 77.23% and Debt Service Expenses were 99.99%
- 14. Motion by Steinmeyer, seconded by Carr to approve payment of \$1,701.47 to KB's Mini Mart. On roll call, AYE: Vacha, Phillips, Carr, Steinmeyer. NAY: None. **MOTION CARRIED.**
